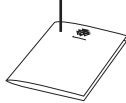

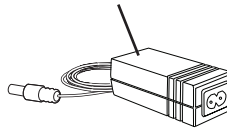

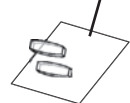

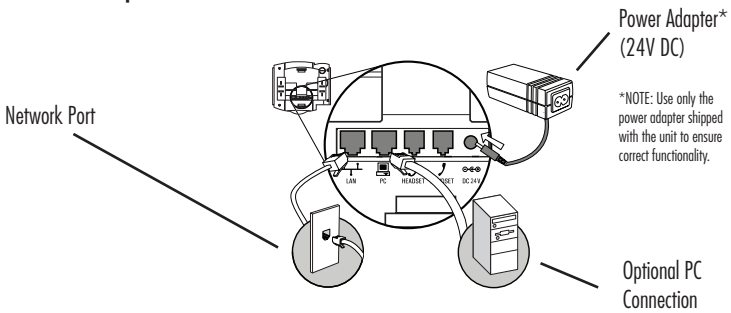

① Connecting Handset and Headset

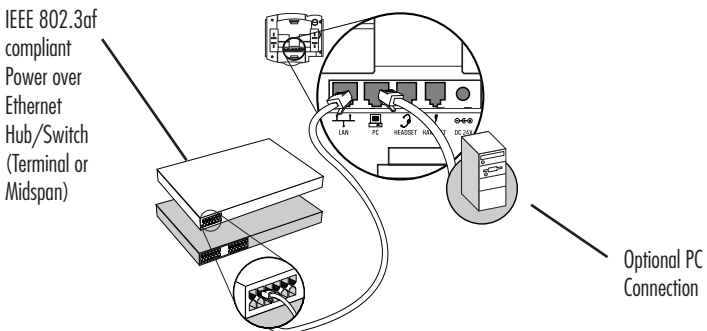


② Connecting Network and Power

Power over Ethernet Option:

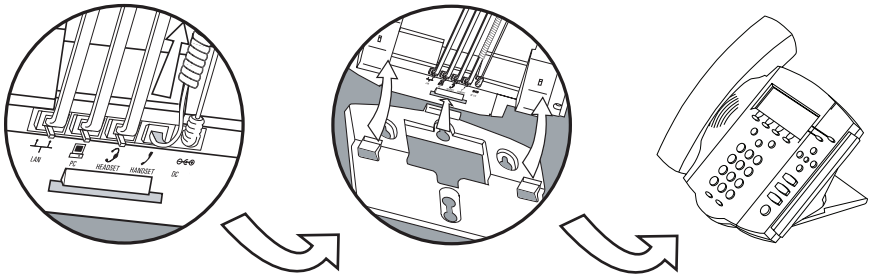


Attaching the Base Stand

The base stand can be attached to the SoundPoint® IP 430 in one of two ways:

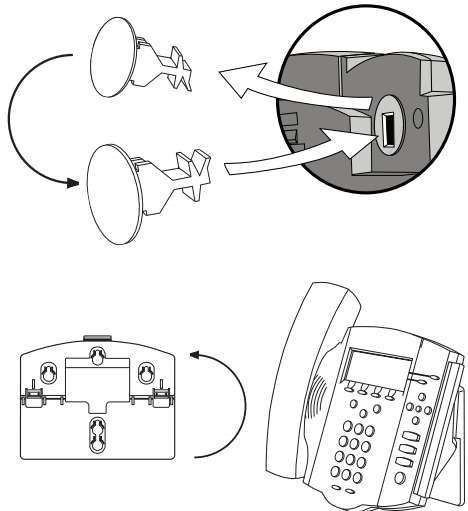
Deskmount Method:

- 1 Connect all cables.
- 2 Align tabs of base stand as shown.
- 3 Snap firmly into place.



Wallmount Method:

- 1 On the back of the phone, remove the key located behind the hookswitch. Reposition it so that the end tab (at 45° angle) is facing up. This will ensure that the handset remains in place within the cradle in a wallmount position.
- 2 With mounting tab of the base unit facing up, fasten the base stand to wall using wall anchors (not included). When base stand is secured to wall and all cables are connected, snap the SoundPoint® IP 430 into place.
